#### 6. Provider Reports

a. Amy: For Red Lion Project met with Congress woman Bonamici; On track to start construction in Novembe; Place people by May or earlier if possible; Workforce housing will be studios and one-bedrooms; family units will be two bedrooms; Permanent units will be studios. Internal conversation around rapid-access in Seaside so people in distress can walk in and speak to someone immediately at our clinic; Built additional two offices in our clinic space. Shelter open since May 7th will be full all the time and assist people getting disability and employment. Child and family three-day clinic for children/youth experiencing mental health disabilities. Signed contract today to hire a substance use disorder clinician to primarily work in the jail and provide suboxone; Working on hiring a full team to transition folks out of jail into services.
